3. "A" Sheets	CLARIFICATION: Wall coverings in rooms 102 and 103 shall be smooth finish FRP, Sequentia Flat by Crane Composites or approved equal, see attached sketch.

INFORMATION ITEMS & ANSWERS TO QUESTIONS

- 4. Layout Work All final layout and elevations will be by the contractor. The owner will provide benchmarks, control points, and rough layout of building corners, storm sewers, light poles, curb-lines (at Pl's Radii points & 100' increments), and paving grade control lines. Contractors shall include in their bids an allowance for this work of \$18,000; layout services will be performed by Klingner & Associates P.C. and directly billed to the contractor. Re-staking of items may incur additional costs above and beyond the stated allowance.
- 5. Testing Requirements Concrete testing will be by the project engineer and paid for by the owner (slump, air %, compressive strength). All other testing (Density, etc.) shall be coordinated and paid for by the contractor; all testing shall be observed by the project engineer and/or owner's representative. Certified testing reports shall be promptly transmitted to the owner and project engineer.
